The learning process is equipped with technological content, ensuring that students have sufficient skills to adapt to the job market oriented towards Industry 4.0. Before completing their studies, students will be equipped with competency certifications from the National Professional Certification Institution (BNSP) and international certification institutions.

- **Curriculum:** There are four specialization fields: financial management, human resource management, marketing management, and operations management that integrated with SAP-ERP content into their courses.
- **Excellent Program:** International activities such as international conferences, competitions, overseas internships, joint degrees, and double degrees. Management UII's partner universities include Saxion University of Applied Sciences, the University of Queensland, Solbridge International School of Business, and others. Additionally, there is ongoing skill development provided annually through the Graduate Employability Development Program (GEDP).

The Accounting Program at UII has been accredited by the international institution ACCA (Association of Certified Chartered Accountants) since 2016. The Accounting program at UII also has extensive partnerships with Certified Practising Accountants (CPA) Australia, the Indonesian Institute of Public Accountants (IAPI), joint degree programs, and student exchange programs with various renowned universities worldwide, such as Solbridge University (Korea), Universiti Putra Malaysia, UiTM Malaysia, and others.

- **Excellent Program:**  
The excellence lies in the fields of forensic accounting, Sharia accounting, and information technology. This is manifested through courses such as ERP-SAP Application System, Sharia Auditing, and Forensic Audit.  
Collaboration with the Forensic Auditor Profession Certification Institute (LSP AF) provides training and professional certification in forensic auditing for students.  
Conducting Tax Brevet training to prepare students to become professional tax accountants.
