The Law Study Program has a curriculum designed to produce Bachelor of Laws with integrity and professionalism based on Islamic values, nationality, independence, and universality. In addition to receiving a Excellent Accreditation by the National Accreditation Board for Higher Education (2021), the Undergraduate Law Study Program is also the first Law Study Program from a private university in Indonesia to receive international certification from the ASEAN University Network on Higher Education for Quality Assurance (AUN-QA) in 2019 and FIBAA Accreditation from Germany in 2022.

The International Law Program was opened in 2001 to create an international learning atmosphere with its teaching staff who are mostly graduates from foreign universities and foreign teaching staff.

The learning process is not only carried out entirely in English, but also carried out with cross-border case study learning methods and practical skills in the field of law, especially related to positive law in Indonesia and Islamic law.

In the classroom, students interact directly with foreign students and receive facilities in the form of a Bridging Program to prepare them for global competition.

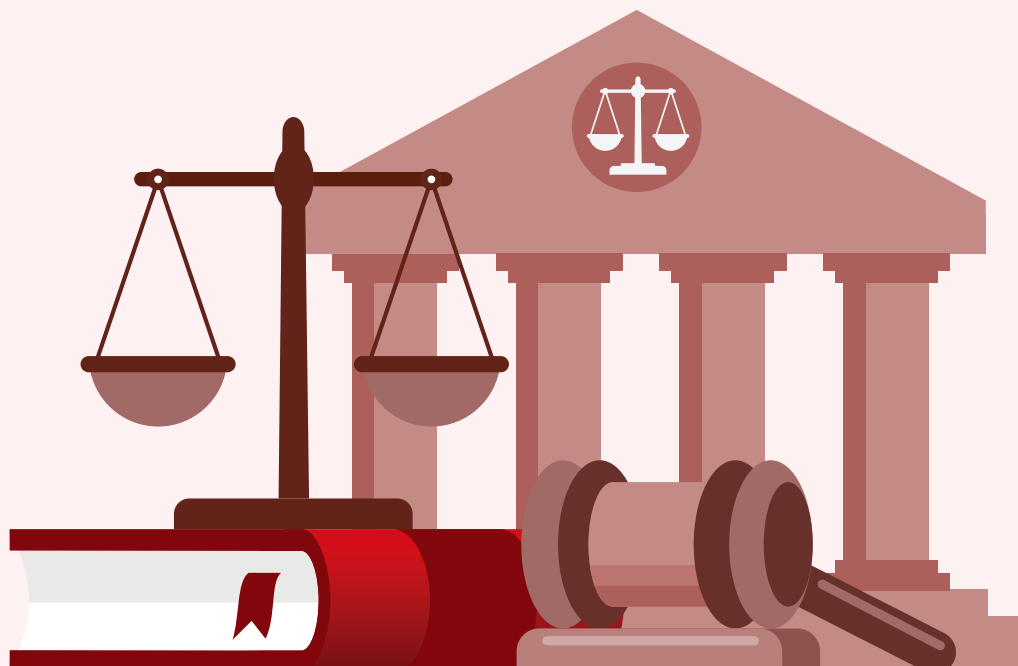
